Advice was sought from Fife Council's Planning Department during the formation of the Local Place Plan, with a response received on 25<sup>th</sup> July 2025 to confirm the group do meet the Community Body test.

We have worked closely with Cowdenbeath Community Council in the formation of the Local Place Plan, from initial discussions in 2024, sharing the Draft Plan with them in November 2025, and hosting a joint Q&A session in person in January 2026. Their letter of support is contained within the LPP Feedback submission detailed below.

## **Regard Given to the Local Development Plan**

The Fife Plan was adopted on 21<sup>st</sup> September 2017 and is due to be updated shortly. This Local Place Plan for Cowdenbeath sets out the local land use priorities for the people who live and work here, as well as a vision for the development of land in the Cowdenbeath boundary in the years ahead.

The Fife Plan carried 12 proposals on land development previously (COW001-COW12) and 7 of these have seen developments completed during the period of the plan, including new stores at the site of the former Police Station and at North End Park, as

well as housing developments at Leuchatsbeath and King Street. We welcome these improvements to our town, bringing much needed housing and jobs to the local area.

We await further development at the site of the former Social Work Office in Factory Road, where Edinburgh City Region Deal funding has been secured for a mixed housing and retail development which will neighbour the town square. We note this development is overdue and await a progress update from the developers, which is why this was not scoped for inclusion in the Cowdenbeath LPP.

Our hope is that the ideas contained within our Local Place Plan can also provide opportunities for further development in the coming years, offering similar positive outcomes for the town and its people.

## **Regard Given to the National Planning Framework**

We have used the National Planning Framework to help inform our categorisation of our Local Place Plan, including a National Planning Policy (NPP) reference on each proposal for ease of reference and alignment.

Our plan aligns fully with the NPF4 themes of Sustainable, Liveable and Productive Places.

## **Regard Given to any relevant Locality Plan**

The Plan 4 Cowdenbeath is Fife Council's locality plan for the wider Cowdenbeath Area covering 2023-26.

## **Regard Given to the Local Area Transport Plan**

Fife Council consulted with local people on the Cowdenbeath Area Local Transport Plan in September 2025, so using the insights gathered during the exercise building the Local Place Plan, a detailed submission was delivered by My Cowdenbeath. Our response can be read here:

Our stated position was that the proposal plan lacked ambition and did not meet the needs of local people and challenged a number of the assumptions and proposals for transport improvements, which we evidenced would harm traffic flow and transport links in the town.

We were pleased to see a number of our proposals and areas of feedback had been updated in the final plan agreed by Cowdenbeath Area Committee when the Plan returned for sign-off.

# **Regard Given to Cowdenbeath’s Community Action Plan (2019-2024)**

The Cowdenbeath Community Action Plan (2019-2024) was published in 2019 as a collaboration between Cowdenbeath Community Council and Coalfields Regeneration Trust.

During the research phase of our consultation work in 2023, the Plan was referenced during tabletop discussions and during meetings with the community council to review its successes. We await the full review of the Plan from its originators, but a number of ideas and initiatives remain relevant to local people and came up again during our community survey. These are likely to be taken forward in a new Cowdenbeath Community Action Plan 2026-2030 due to be published later this year.

## **Reasons for Amendments being sought to the LDP**

Fife Council are reviewing the Local Development Plan (LDP) for Fife, and therefore we feel the proposals contained in the Cowdenbeath Local Place Plan provide adequate detail to include in any new LDP when it is published. Development across a number of neighbouring places, such as Duloch in Dunfermline, have progressed at pace, and we aim to see investment in growth and infrastructure in Cowdenbeath as an aspiring town with great facilities for families and individuals to have a safe, prosperous life here.

We are not seeking amendments to the current LDP since it is due to be refreshed shortly and a number of the previous proposals have now been completed.

## **Community Support for the Local Place Plan**

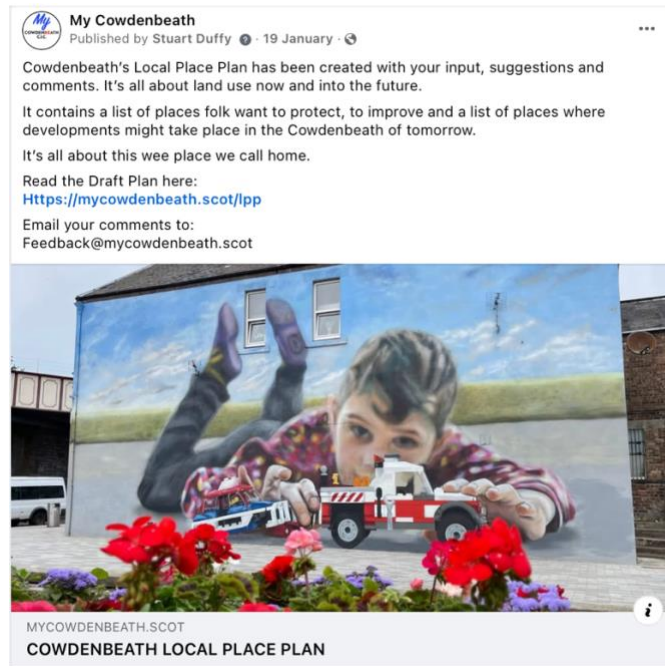
The views and ideas of local people have been our primary focus throughout the formation of this Local Place Plan.

Our community survey had more than 1,100 responses; our public engagement days on the High St and at local events had more than 80 visitors; our Mapping Days at the Maxwell Centre had nearly 30 visitors in person; and, our Draft Local Place Plan has been viewed and downloaded from our website nearly 350 times.

We received 5 responses during the 28-day feedback period, all positive, including support for the plan from Cowdenbeath Community Council.

These engagement actions and the lack of any negative feedback during public consultation periods demonstrate the support for the work of My Cowdenbeath in this venture.

Through discussions during the community council Q&A and written feedback received via the feedback mailbox, we made 3 adjustments to the final plan. **INFORMATION NOTICE OF INTENTION TO PUBLISH A LOCAL PLACE PLAN**

I am writing to you on behalf of My Cowdenbeath CIC to provide you with notice of our intention to submit a Local Place Plan to Fife Council under the Town & Country Planning (Scotland) Act 1997, covering the community council boundary of COWDENBEATH.

My Cowdenbeath CIC, acting as an eligible community body, is obliged to inform you, as either a local elected representative for the Cowdenbeath area, or as a Community Council which adjoins our proposed Local Place Plan area, of our intention to submit a Local Place Plan under s.4(1) of the Town & Country Planning (Local Place Plans) (Scotland) Regulations 2021.
